# THE APPROACH

After several successful syndicates, we have defined the following common strategy for LIBERTY RACING:

- Professional selection of top horses by an experienced and well connected team of experts from various areas (breeding, exterior, pedigree, veterinary medicine, training).
- In the selection of horses, the main emphasis is on successful German families and proven sires, whereby the focus is on classic potential of the horses for the Derby or the Oaks. LIBERTY RACING 2024 Gold also considers less proven sires with the purchase decision relying on the exterior of the horse.
- When selecting horses, we use the latest IT technology and proven successful applications (such as equineline.com, thoroughbreddailynews.com or g1goldmine.com) and consult successful trainers and very successful auction buyers in addition to the existing team. The selection process starts long before the auction in stud farms' pastures and in the intensive study of the horses' pedigrees. The knowledge of families that have been successful for generations is used here to ensure the success of the syndicate.
- Pre-training by experienced experts and training with top trainers.
- Professional management guarantees selection and preparation of horses.
- Lower risk of loss compared to buying a horse as individual owner - one single payment generates shares of several horses.
- Using the strength of German breeding (especially stamina) and its worldwide successful dam lines through targeted purchases.
- Utilising international network and experience for worldwide sales.
- Experiencing horse racing together - on the racecourse, in the morning workouts, at the stud.
- New syndicates every year.
- Great events for shareholders - leisure activities at the highest level (with lectures to support the entry into the world of thoroughbred).
- Not a yield object.
- All decisions and services for LIBERTY RACING are made by the team of LIBERTY RACING UG.
- All syndicate members share the awareness that even if several horses are purchased, a full loss of the money invested can occur. Horse racing syndicates are hobby and are part of an upscale recreational activity, not a yield object.

# LIBERTY RACING 2024 – SYNDICATES AT A GLANCE

There will be at least two syndicates in 2024. The classic Platinum syndicate offers 28–32 shares, each of which will cost €27,500.

As soon as the Platinum syndicate is sold out, there will also be an entry-level syndicate in 2024: LIBERTY RACING 2024 Gold! Here, a share costs €13,500; 28–32 shares are available and 3 horses will be acquired.

Should these two syndicates sell out quickly and demand is high, we will offer LIBERTY RACING 2024 AUSTRALIA as an option. Here, 12–17 shares are available at the cost of €40,000 each. The horses will not be sold as three-year-olds, rather they will be exported to Australia after the Derby if they are of the right quality. They will race there until the end of their 5th year (Australian age) for LIBERTY RACING 2024 Australia. Only then will they be sold. We hold the dream of winning the Melbourne Cup.

Sales/Dissolution:	After 2026 Derby sale or export to Australia. Sale at the end of five-year-old season in Australia. For an export to Australia, the horses have to qualify of Australian stayer races and the majority of the shareholders must agree to the sale. Should earnings not properly cover transport costs, each shareholder might be asked to contribute additional €10,000 by 07.30.2026. A detailed interim settlement takes place on 12.31.2027. All proceeds and profits achieved after deduction of all costs (purchase, training, veterinary, etc.) are paid out to the shareholders.

# THE COSTS

Depending on the syndicate, costs per share vary. In LIBERTY RACING 2024 Platinum syndicate, each share costs 27,500 euros. In LIBERTY RACING 2024 Gold, each share costs 13,500 euros. Should LIBERTY RACING 2024 Australia be founded, each share will cost 40,000 euros. The Gold and Platinum syndicates will be settled on 31.12. 2026. If LIBERTY RACING 2024 Australia is established, this syndicate will not be settled until 31.12.2027, as the horses are expected to race in Australia from the end of 2026 to 2027.

After deducting all expenses (purchase, training, veterinarian, etc.) each shareholder will receive their percentage share of all available funds.

It is possible to purchase several shares.

LIBERTY RACING Management UG receives 5 percent per syndicate share for the overall management, 5 percent of each cash prize earned by a syndicate's horse and 5 percent from each horse sale when the syndicate is dissolved.

Should LIBERTY RACING Management UG make a profit from a syndicate after deducting all costs, these profits will be invested in new syndicates and the popularisation of horse racing.

Further costs such as purchase price for horses, auction fees, veterinarian and agent fees, training costs, transportation of the horses, race colours, etc. are paid by LIBERTY RACING 2024 from the share deposits.

Purchasing a share covers everything up to the dissolution of the syndicate. The payment is made to a LIBERTY 2024 account 14 days after signing the syndicate share purchase agreement. The syndicate shareholders are not obliged to make additional payments.





# THE FOUNDERS OF LIBERTY RACING

Lars-Wilhelm Baumgarten and Nadine Siepmann are the founders of LIBERTY RACING and both have been horse racing enthusiasts since childhood. The breeding of successful thoroughbred horses and the purchase of fast racehorses are a great passion for both of them. To experience thoroughbreds together with friends and acquaintances is a real pleasure for the entrepreneurial couple. Freedom and dignity for people and animals and the love for the thoroughbred horse carry their founding spirit and also unites many parts of their life vision.

**DJANGO FREEMAN** – Purchase on the basis of €80,000 prior to first start - group winner, 2nd in IDEE 150th German Derby – sold to Australia – GAG 95.5.

**BE MY SHERIFF** – 2-time Group winner (Carl Jaspers-Preis, Gr.2 and Fürstenberg-Rennen, Gr.3) – 96.5.

**KALIFORNIA QUEEN** – Bred jointly with Nick Proschwitz – €60,000 purchase at the BBAG Auction Sale – Gr.2 winner in the 2020 German Oaks trial at Hoppegarten – GAG 93.

**KALDERA** – €11,000 BBAG purchase – classic winner in the German St. Leger Gr.3) – Champion Mare – GAG 94.
